


Fig.1 Basic outline of a TSE circuit

#### Brief history of the places to be visited

Sasan-Gir: Gir Forest National Park is a wildlife sanctuary in Gujarat, western India. It was established to protect the Asiatic lions, which frequent the fenced-off Devalia Safari Park, along with leopards and antelopes. Gir Jungle Trail, outside the fenced area, traverses deciduous forest and is home to wildlife including vultures and pythons. More than 100 Cement factories at Junagadh factories are located at a distance of 50km (Stay - 2 nights at The Fern Gir Forest Resort)



Two hour Seminar on the aspects pertaining to Micro, Small and Medium Enterprises was organized and successfully concluded at EMA hall on 21st September and around 70 members participated.

Secretary **Mr. Nirmohi Shah** welcomed all the members and the event started with the rendition of National Anthem. He introduced speaker of the evening Mr. S. Vijaykumar and requested President **Mr. Niren Dharia** and Ex-officio **Mr. Nishel Shah** to honour with Memento's.

President in his short speech informed the audience about the lack of awareness of MSME policy and how registering with MSME will help members to grow their businesses. He requested S. Vijaykumar to explain in detail how MSME registration will help EMA members.

Mr. S Vijaykumar explained each and every aspect of the MSME in details ie. Registration Process, benefits and Cluster development.

Brief about MSME: The Micro, Small and Medium Enterprises (MSME) sector has emerged as a highly vibrant and dynamic sector of the Indian economy over the last five decades. It contributes significantly in the economic and social development of the country by fostering entrepreneurship and generating largest employment opportunities at comparatively lower capital cost.

Ministry of MSME Government of India has a number of schemes and programmes to help and assist entrepreneurs' especially small businesses.

The Ministry of MSME runs various schemes aimed at financial assistance, technology assistance and upgradation, infrastructure development, skill development and training, enhancing competitiveness and market assistance of MSMEs.

#### **Development Schemes:-**

Udyog Aadhaar Memorandum (UAM) MSME SAMADHAAN. Credit Guarantee (CGTMSE). Cluster Development Programme. Consortia & Tender Marketing. Credit Facilitation through Bank. Single Point Registration Scheme. Exhibitions. Marketing Assistance.

#### Benefits of being registered under MSME

#### 1. Collateral Free loans from banks

The Credit Guarantee Fund Scheme for Micro and Small Enterprises (CGS) was launched by the Government of India to make available collateral-free credit to the micro and small enterprise sector. Both the existing and the new enterprises are eligible to be covered under the scheme.

2. <u>Very easy to get Licenses, approvals and registrations:</u> It has made very easy for enterprises that are having MSME Certificate to obtain Licenses, approvals and registrations on any field for their business from the respective authorities as they can produce the Certificate of MSME Registration while making application. Easy process to supply in government organisation like ONGC, Railways, IOCL etc.

#### 3. Protection against delay in payment

The Ministry of Micro, Small and Medium Enterprises gives protection to MSME Registered Business against delay in payments from Buyers and right of interest on delayed payment through conciliation and arbitration and settlement of dispute be done in minimum time. If any micro or small enterprise that has MSME registration, supplies any goods or services, then the buyer is required to make payment on or before the date agreed upon between the buyer and the micro or small enterprise. In case there is no payment date on the agreement, then the buyer is required to make payment within fifteen days of acceptance of good or services. Further, in any case, a payment due to a micro or small enterprise cannot exceed forty-five days from the day of acceptance or the day of deemed acceptance. In case of failure by the buyer to make payment on time, the buyer is required to pay compound interest with monthly interest rests to the supplier on that amount from the agreed date of payment or fifteen days of acceptance of goods or service. The penal interest chargeable for delayed payment to a MSME enterprise is three times of the bank rate notified by the Reserve Bank of India.

#### 4. <u>Reduction in rate of Interest from banks</u>

The rate of Interest for enterprise that has MSME registration are lower as compare to other enterprises. Certain targets are set for banks' lending to the Micro and Small Enterprises. The banks' have to achieve a 20% growth in credit to micro and small enterprises and 10% annual growth in the number of micro enterprises accounts and 60% of total lending to Micro and Small Enterprises sector.
